i) Students must attend all classes regularly and appear in all tests.

ii) If a hosteller, for any reason whatsoever, discontinues his/her coaching or joins any other course or employment, he/she must obtain prior permission from the authority at least one month in advance and vacate the hostel immediately thereafter. The hosteller is required to pay the full monthly fee for the entire current month. This condition applies even if the hosteller leaves on the first day of the month.

Further, on 31st March 2027, the admission will stand automatically cancelled, and all students must vacate the centre on or before this date. No excuses will be entertained.

iii) The monthly fee must be paid within the third week of every month.

iv) Candidates must apply to the authority at least three days in advance to withdraw their original documents. Documents will be released only for a limited period after verification of the genuine reason.

v) If a hosteller needs to remain away from the hostel due to any exigency, he/she must personally submit a leave application to the office at least three days prior to the leave date, clearly stating the reason, and obtain prior written permission. Failing this, appropriate disciplinary action may be taken.

Every hosteller shall maintain and observe the following:

- Strict discipline, a peaceful atmosphere, and decent behaviour in the hostel. Shouting, misbehaving, talking loudly, or causing disturbance in any manner will not be tolerated.
- Rooms and common areas must be kept neat and clean. Any issue regarding cleanliness should be reported to the office.
- A spirit of friendliness and cooperation should be maintained among all.

- vi) Any act of indiscipline or indecent behaviour towards staff or faculty will be dealt with seriously, and strict disciplinary action will be taken against the student concerned.
- vii) No visitor, guest, relative, or outsider is allowed to enter the hostel premises without prior permission. If any hosteller is found bringing a visitor into any part of the hostel, including rooms, immediate disciplinary action will be taken.
- viii) Electricity must be used carefully and economically. Lights, fans, geysers, coolers, and other electrical installations must be switched off when not in use. Hostellers are not allowed to bring or keep any electrical or electronic appliances from outside. Items such as electric stoves, water heaters, tape recorders, radios/transistors, portable TVs, and other electronic gadgets are strictly prohibited.
- ix) Water taps must be kept closed when not in use. Water should be used economically, and wastage must be avoided.
- x) Complete silence and proper, decent behaviour must be maintained while using or passing through the hostel premises.
- xi) The hostel administration reserves the right to remove or expel any hosteller at any time without assigning any reason. In such cases, the hosteller must vacate the hostel immediately.
- xii) If it is found that a hosteller has obtained admission by false representation or by submitting forged or false documents, he/she will be expelled immediately, and the security deposit will be forfeited.
- xiii) All hostellers are required to attend lectures, meetings, group discussions, competitions, or any other programmes arranged in the hostel.
- xiv) In case of any grievance, the hosteller should approach the administrator.
- xv) Ragging or mischief of any kind is strictly prohibited. Severe punishment will be imposed for such offences.
